## What is Cumbria Christian Youth Camp?

Cumbria Christian Youth Camp (CCYC) is a camp which is held each summer at Braithwaite Memorial Institute, near Keswick, with the purpose of telling young people about the Lord Jesus Christ. It is open to boys and girls between the ages of 11 to 16.

CCYC is a Trust and registered Charity No.510036.

Camp is limited to 160 campers (early booking advised).

## What about safety?

Every precaution is taken to ensure safety throughout the holiday. All activities are supervised by responsible adults, and the outdoor pursuits are carried out under qualified supervision.

All travel will be by either coach, minibuses (with front facing seats) or private car and will again be supervised.

Permission for a child to leave the site is required from a Senior Leader and the signature of a Parent / Guardian

A qualified First Aider is at Camp throughout the week.

# HOW DO I APPLY?

## How much will Camp cost?

The cost of Camp is £95, this includes:

- **transport** to and from Camp (from points shown);
- **full board** (due to limited cooking facilities on Camp it is not possible to cater for special diets, unless there are essential medical reasons);
- **main activities**;
- **campers sleep in tents**, boys and girls are separated, each with a Tent Leader.

A Tuck Shop is provided and a Bank for any pocket money.

## What's next?

Once your application has been acknowledged by letter or email you will be sent further details 3 weeks before Camp, detailing:

- Transport times and pick-up points;
- What to bring to Camp;
- Any other last minute information.

## How do I apply?

If you wish to come to Camp and agree with the Camp rules on the back page:

1. Complete the enclosed form.
2. Send the completed form along with a £20 deposit to the address below.

# PARENTS INFORMATION

## RULES

For Camp to run SAFELY and SMOOTHLY the following rules must be followed:

1. The allocation of tents will be by age and are final.
2. Only the main site entrances will be used
3. No-one should leave Camp without the permission of a Senior Leader and the signature of a Parent/Guardian.
4. All groups leaving Camp for off-site activities must be accompanied by a Tent Leader.
5. No cigarettes or e-cigarettes, no alcohol, no non-prescriptive drugs, no dangerous weapons. These must be given to Tent Leaders at the beginning of the week.
6. All medicines are to be handed to the Nurse on arrival.
7. Mobile phone usage on the site is restricted to that defined within Camp policy which will be detailed in the pre-Camp letter.
8. Cumbria Christian Youth Camp cannot accept responsibility for personal equipment or clothing lost or damaged at Camp.

*Anyone breaking Camp rules will run the risk of being asked to leave the camp.*

## INSURANCE

Cumbria Christian Youth Camp takes out a Public Liability Insurance Policy for the Camp, we would recommend that if you require Personal Accident and Belongings cover you seek advice from an Insurance Broker.
